#### **DAY 1: ARRIVE SAN DIEGO**

ago. Famous for the Annual Return of the Swallows, the mission is the "Jewel of the California Missions." This afternoon travel by motorcoach south along the famous beaches of San Diego and pass by Torrey Pines Golf Course. Then stop in picturesque La Jolla for leisure time to wander, shop or maybe visit the famous La Jolla Cove. The late afternoon and evening are at your leisure to enjoy San Diego.

#### **DAY 3: SAN DIEGO CITY TOUR - USS MIDWAY MUSEUM - HARBOR CRUISE**

This morning enjoy a San Diego City Tour to see the waterfront, Downtown, Gaslamp Quarter, Pt. Loma with Cabrillo Monument, historic Spanish Old Town and Coronado Island. Later, relax and enjoy the scenery as you travel to the picturesque Temecula Valley to visit a local winery for a Wine Tasting Experience. The Temecula Valley features over 40 wineries







offering award-winning wines due to its micro-climate of morning mist, midday warmth and cool ocean breezes. Return to your hotel for an evening at your own pace.
